Ermel – That the Rural Municipality of Cupar #218 has no objections to the directional bore from Sasktel on the road between the NW-08-23-18-W2 and SW-17-23-18-W2.

#66/18 FIRE BAN:

Mills – That the Council of the Rural Municipality of Cupar #218 ratify the decision made on May 16, 2018 to impose a fire ban in the Municipality. The conditions are as follows:

The Rural Municipality of Cupar #218, the Village of Markinch and the Town of Cupar have issued a fire ban effective May 16, 2018. This ban includes all open fires, camp fires, fires used for cooking, briquette barbecues, burning barrels, chimneys, briquette fire pits, portable fire pits including those contained in designated fire facilities and the discharge of all fireworks.

The ban does not apply to fires contained in cooking appliances fueled by propane or natural gas such as BBQ's or Coleman stoves.

This order takes effect on May 16, 2018 at 10:00 a.m. and is in effect until further notice. Please be advised a minimum fine for starting a fire is \$500 plus the cost of the fire call.

Blaser – That the Rural Municipality of Cupar #218 agree to the request from the family of Hazel Voss to transfer a small piece of abandoned road allowance on the NE-34-24-16-W2 to the Voss family on the condition that they cover all the costs of the title transfer including the cost of advertising and the transfer of the title. Further, the request to build a fence or build up the road on the unmaintained road allowance adjacent to the RM gravel pit in the Rural Municipality of Touchwood is not of interest to Council at this time.

#72/18 **2018 BUDGET**:

Ermel – That the Rural Municipality of Cupar #218 adopt its 2018 budget. The budget is based on an annual income of \$1,469,700 and expenses of \$1,552,120, which yields a small deficit of \$82,420, which will be covered by accumulated surplus.

#73/18 **2018 MILL RATE**:

Nakonechny – That the Rural Municipality of Cupar #218 establish a mill rate of 7.5 for the 2018 taxation year to meet the needs of the budget. Further, the mill rate factors as outlined in Bylaw #2017-04 which has the following mill rate factors:

#74/18 2018 BEAVER BOUNTY PROGRAM:

Mills – That the Rural Municipality of Cupar #218 acknowledge the acceptance into the 2018 Beaver Control Program and the decrease in funding to \$3,333. The program will cover:

- Up to \$15 per adult nuisance beaver removed by licensed trappers within the designated RMs & FNBs (based on a 50/50 cost share of \$30 payment per tail);
- Up to \$500 for pond leveler materials and installation (with verified invoices);
 and
- Up to \$500 for beaver deceiver materials and installation (with verified invoices).

Further, the Rural Municipality of Cupar #218 will appoint Tyler Duschene and Trevor Macknak as licensed trappers designated to remove beavers and cover them for 50% of the beavers removed to date. Going forward, the beaver removal must be pre-approved as being a nuisance beaver prior to removal.
