# #125/19 TOWN OF CUPAR REQUEST:

Frank – That the Rural Municipality of Cupar respond to the letter from the Town of Cupar. The letter from the Town to the RM agrees to not pursue annexation of the newly developed Prairie Coop Agricultural Centre and Service Station. The Town of Cupar has indicated they pay for 16% of water service and 49% of sewer service with tax revenue vs utility revenue and that by extending the service to the Rural resident, the Town is at a disadvantage. The Town of Cupar requests that an Inter-Municipal Agreement be put into place with the following objectives:

- The property containing the Co-op development remains within the RM's jurisdiction in perpetuity.
- The RM agrees to provide the Town with an annual payment equal to 25% of the annual taxes for the Co-op development
- As land continues to be subdivided and developed, the RM support the annexation of future developed lands.
- Define a basis for ongoing revenue and expense sharing for new development
- Investigate opportunities for joint economic growth.

While the Rural Municipality of Cupar #218 agrees that an Inter-Municipal Agreement to address future development along Highway #22 will ease the process, the above terms are not satisfactory. The reply letter will address Council's concerns and propose a meeting to discuss the possibility of a mutually beneficial agreement.
