#137/19 BEREAVEMENT LEAVE POLICY:

That the Rural Municipality of Cupar #218 pass the following Bereavement Policy for Employees:

In the event of a death in a staff member's immediate family, the staff member is entitled to a leave of absence with pay of up to three consecutive working days. An additional two days of leave with pay may be granted by the supervisor for extensive travelling, making funeral arrangements or settling estate matters. This policy should be interpreted with proper sensitivity.

Immediate Family is defined as spouse, common-law spouse, same-sex partner, child, sibling, parent, mother/father-in-law, sister/brother-in-law, daughter/son-in-law, grandparent and grandchild. Similar consideration may also be given to foster child, foster parent, ward or other individual close to the employee. Time off without pay for attendance at the funeral of a deceased friend or relative, other than relatives as mentioned above, is allowed at the discretion of the Council.
